## BRIDGEHAVEN CONFIDENTIALITY GUIDELINES

Bridgehaven serves people in a variety of ways. In each setting, confidentiality is of **utmost importance**. Each time a person enters the office or calls for information, he or she can be assured that all discussions are strictly confidential. The following guidelines must be considered of extreme importance by all staff and volunteers of Bridgehaven.

1. No one may have access to the business area of the office without special permission from the director (exception is use of the phone.)
2. No one may have access to records, files, correspondence, or staff knowledge of individuals without special permission from the director.
3. No information about a client is to be given to anyone but that client.
4. Written consent from the clients must be obtained for Release of Information in a referral situation.
5. An attempt must be made to conceal clients' names in the reception/business areas when other clients are present.
6. Client files or intake forms must **never** leave the office.

To emphasize this further, the following will help you understand when confidentiality is broken:

1. When any information of any kind concerning a client is given over the phone to anyone without written consent of that client.
2. When test results are given over the phone. (It is impossible to have identification of an individual on the phone.)
3. When a client is called by name in front of other people.
4. When a client is in the waiting room and someone comes into the office that he/she knows. This may be out of our control, but please separate clients into the two rooms as soon as possible. Never meet with them together unless they request it.
5. When staff tells about their "day at the office" and use the client's name.
6. When a client sees other client's names on forms or the schedule book. *Keep client information turned over or out of sight when they are not in your hands or the client's hands. Keep the schedule book covered.*
7. When anyone is given access to anything in the files in any way, without the director's permission.

## BRIDGEHAVEN GUIDELINES FOR VOLUNTEERS

(Remove this page and keep it for your future reference)

The primary goal of Bridgehaven is to bring the good news of Jesus Christ in both word and action to clients. In light of this goal, volunteers are encouraged to remember the following:

- We are worshipping and serving Jesus Christ. We are not in the ministry strictly to serve clients, but also to worship and serve Him. In worshipping and serving Him, He shall enable us to minister to those who come to the center.
- Volunteers must be continually in prayer, studying the Word and in fellowship in a local church.
- God is as interested in transforming volunteers' lives through the work of the center as He is in the salvation and transformation of the women and men who come to the center.
- Honoring God as we serve Him is the goal of the ministry. While we record the number of clients who come in and the number of clients who do or do not have abortions, this must not become the center's definition of success.
- God is teaching us through all the circumstances of daily operation and outreach, as well as serving on the boards and in committees. The "hands-on" part of the ministry is not the only area God will use for transformation. Being faithful when there are no clients and finishing up office work (sorting clothes etc.) are a test of commitment.
- God will use the center to rework priorities in your life, test and strengthen you and reshape relationships.
- Take the temperature of your home life often. No ministry is more important than your family. Lines of communication need to stay open continually as your involvement in the ministry develops. Be realistic with your time commitment before the Lord.
- The ministry is always growing and changing. Be flexible and open to God's leading at all times.
- God will teach you patience and will give you strength to deal with the challenges of the ministry as you submit to Him in prayer, Bible study and worship.
- Do not compare your progress of development with other volunteers. You have a unique set of gifts that He will strengthen and refine. He uses different pressures and experiences to transform each person.

## A Word about Wording

The words and phrases we use to describe the ministry, our services, and the issues we address are really important. We want to use words that are clear and that avoid perpetuating stereotypes or myths.

**Pregnancy Support Center:** this is the phrase to use when describing what type of organization Bridgehaven is. We want to emphasize that our services are pregnancy-related and that we are here to be a resource.

Example: Bridgehaven is a pregnancy support center.

**Avoid:** *Crisis Pregnancy Center* (the word “crisis” reinforces the perspective that a unplanned pregnancy is a negative and fearful event); *Pregnancy Outreach Center* (“Resource” is a better, more accurate term than “Outreach,” especially to potential clients)

**Unplanned Pregnancy:** use this phrase to describe the typical pregnancy of our clients because it provides a neutral tone. “Unintended Pregnancy” is also acceptable. Example: Bridgehaven reaches out to women experiencing an unplanned pregnancy.

**Avoid:** *Crisis Pregnancy* (see reasons above); *Unwanted Pregnancy* (we do not want to perpetuate the label that just because a pregnancy, and thus a child, is unplanned, it is unwanted); *Pregnancy Out-of-Wedlock* (both single and married women experience unplanned pregnancy and both can be vulnerable to abortion)

**Parent:** this is the word we use to describe the choice of a woman to carry her baby to term and to raise that child (rather than place the child with an adoptive family). The word “parent” emphasizes the life-long commitment to the child. Example: The client has chosen to parent.

**Avoid:** *Keep the baby* (this phrase implies that women choosing to make an adoption plan rather than parent are abandoning their child).

**Make an adoption plan; Choose an adoptive family; Place her child with an adoptive family:** these are acceptable phrases to describe the choice of adoption. To say simply that a woman is choosing adoption is also acceptable. Example: The client has chosen an adoptive family for her child.

**Avoid:** *Give up for adoption* (this phrase perpetuates the myth that adoption is abandonment); *Put up for adoption* (this phrase originates from a time when children were put up on a stage so they could be examined to be taken home, maybe to be servants; it perpetuates negative stereotypes that adoption is impersonal and cold).

**Carry to term:** this is a neutral way of saying a woman has chosen life. Saying a woman “chose life” is also acceptable, but depending on the audience, this can stir up reactions. If you are in a setting where the audience is pro-choice or mixed, “carry to term” may be a more appropriate choice. Example: Bridgehaven offers women comprehensive support so they feel like carrying to term is a realistic option.

**Life-affirming:** this a less political way of saying we value and uphold the sanctity of human life. Example: Bridgehaven helps equip women to make life-affirming choices.

**Avoid** in some contexts: *Pro-life* (this isn’t a bad description when you are with a life-affirming audience, but even then, the phrase carries a lot of political baggage. Many people see protestors in their mind when they hear “pro-life.” We want to avoid anything that might make an abortion-vulnerable or post-abortive woman hesitate to come to us for help).

**Sexual Integrity:** this phrase describes the emphasis of our prevention efforts. It includes reserving sexual activity for marriage, but goes beyond that to challenge students to consider the movies/TV they watch, the music they listen to, who they spend their time with, what's on their facebook page, etc.

**Reserving Sexual Activity for Marriage:** this phrase accurately describes the boundaries Bridgehaven advocates and helps to avoid hot-button words.

**Avoid:** *Abstinence* (this is not a bad term, but it has been drawn so much into the political battleground, that at this point, it may carry more baggage than it's worth)

**Client Support Services:** this describes everything we do to provide ongoing support for pregnant and parenting clients, this includes life skills classes, earned assistance with food, clothing, diapers, and formula, layettes, and annual earned benefits for Thanksgiving and Christmas food boxes and Christmas Room gifts.

**Avoid:** *Food Pantry* (this implies that we have the traditional model of food assistance where people can stop in and pick up food boxes. Our food assistance is a benefit of attending classes, not an isolated resource); *Clothing Closet* (for the same reasons; this is not an isolated resource).

## Explaining: “What is Bridgehaven?”

### Overview:

- Bridgehaven is a pregnancy resource center whose mission is to **empower choices for life through Christ-centered education and support**. The ministry accomplishes this mission with a comprehensive approach through three key areas of services: counseling, client support, and prevention.

### Counseling Services:

- To empower choices for life, we must be there during that crucial vulnerable time when a woman is facing an unplanned pregnancy and all the fear and pressures that come along with it. Bridgehaven does this by offering free pregnancy tests and options counseling. Peer counselors help women and men consider life-affirming options like adoption and parenting. They also share accurate information about abortion procedures and risks, so those clients considering abortion really understand the implications of their choice. Most of all, peer counselors help women connect with their own heart and work through their fears. Counselors continue to follow-up with each client, providing her support throughout her pregnancy.
- We know that many women have already chosen abortion. In fact, if current rates continue, 1 in 3 women will have an abortion by the age of 45. Abortion is so devastating to women and men, and many struggle with “post-abortion stress” or PAS, with symptoms like depression, relationship difficulties, anniversary grief, and substance abuse. Often intense feelings of guilt and shame keep women from seeking healing, but Bridgehaven is a safe place for both women who have an abortion in their past. Bridgehaven offers biblically-based recovery classes to help women realize their forgiveness in Christ and experience the healing God has for them. There is no judgment here! The classes are even led by women who are post-abortive themselves.

### Client Support Services:

- The number one reason that women choose abortion is a lack of support. Thus, to empower choices for life, we must offer ongoing, holistic support. Bridgehaven does this through the Earn While You Learn program. Pregnant and parenting clients take empowering classes in key areas such as family relationships, career skills, and spirituality. Classes are designed to help women grow personally and move toward independence.
- By attending class, clients “earn” weekly assistance of basic needs items like food, clothing, diapers, and formula. We celebrate their commitment to the program annually, by giving them benefits of holiday food boxes and Christmas gifts for their children when they attend at least 60% of classes.
- Bridgehaven offers free childcare during all classes, to meet this need for parents but also to minister to their young ones!

### Prevention Services:

- While we must be there in that decision-making moment and for ongoing support, a third crucial part of empowering choices for life is reaching young women and men before they are facing an unplanned pregnancy. This is where prevention services come in.
- The goal of prevention services is to actively promote the appreciation for and practice of sexual integrity through age-appropriate, factual and medically-accurate education, peer-to-peer mentoring and partnerships with like-minded organizations.
- Bridgehaven accomplishes this goal through many outreach efforts. One such effort Veracity peer-to-peer mentoring group, where high school and college students committed to sexual integrity go into middle and high school classrooms to speak with students about pressures, risks, boundaries, and their own personal reasons for choosing sexual integrity.
- Bridgehaven is bringing the message of sexual integrity to the community in many other ways: presentations and interaction with church youth groups, the establishment of support groups for pregnant and parenting students in

colleges, high schools, and even middle schools, and engaging the college community regarding issues like sexual activity, healthy relationships, and abortion.

How to help:

- **There are many ways to join in this mission to empower choices for life!**
- **Pray!** Bridgehaven is a ministry wholly dependent on the work of Christ in us. Thus, we are committed to prayer. The staff begins each day with an hour of prayer and worship before we open our doors. Would you join us as an intercessor?
- **Shop!** Bridgehaven has a resale shop, Treasures, with high quality used (and even some new!) clothing, housewares, toys, and more. Everything sold in the store is donated, and all proceeds go directly to benefit Bridgehaven. We also need a constant flow of donations for the store, so check those closets. Remember, you're not just shopping; you're supporting the ministry!
