GENERAL STATEMENT OF DUTIES

The Prevention Educator is responsible assisting Director of Prevention in providing Sexual Risk Avoidance education to schools, organizations and agencies in the Cedar Rapids community and surrounding areas.

EXAMPLES OF ESSENTIAL WORK

- Become proficient in Sexual Risk Avoidance (SRA) curriculum for presentation to schools and community youth.
- Present other topical information related to sexual integrity and healthy relationships to various audiences, including teens, young adults, and parents
- Pursue eventual certifications in SRAS and Real Essentials
- Assist in the development and revision of lesson plans, scope, and sequence of curriculum
- Assist with phone calls and appointments with school administrations, teachers, youth pastors, agency directors, and community leaders
- Assist in keeping accurate records and statistics for Prevention programming
- Network and promote sexual integrity in the community among agencies, churches, schools, employers and organizations
- Assist in recruiting and training volunteers for Prevention programs
- Represent Bridgehaven to the community through correspondence, meetings and speaking engagements as requested by the Prevention Director
- Promote Prevention services within the community
- Participate in fundraising events as requested by the Prevention Director and/or Executive Director
- Other responsibilities as delegated by the Prevention Director
